According to the Art. 2.4 and 2.5 of the Memorandum and Articles of this Association, any ordinary member or corporate member shall be eligible to apply and be admitted as a voting member if:

- 已連續或累計成為普通會員或機構會員不少於三年;且 he has been an ordinary member or a corporate member for a continuous or an aggregate period of no less than three years; and
- 2. 沒有拖欠會費;且 has not any arrears in membership fees outstanding; and
- 其申請由一名投票會員提名,並由另一名投票會員附議提名(兩人均須認識申請人)。 his application for voting membership is proposed by one voting member and seconded by another voting member (both of them should know the candidate personally).
